- Definition: The time series show the proportion of sustainable development indicators for Germany that fully, partially or not at all correspond to the required disaggregations. Relevant disaggregations are those that are explicitly mentioned in the title of the indicator. Based on this principle, a relevant disaggregation is usually defined as any classification that follows "by" in the title of the indicator, for example "by age and gender". This working definition excludes cases where the title of the indicator contains sub-indicators, such as indicator 3.5.1 'Coverage of treatment interventions (pharmacological, psychosocial and rehabilitation and aftercare services) for substance use disorders' treatment interventions are a sub-indicator rather than a disaggregation. Also excluded are all references to the sample for which the indicator requires data. For example, Indicator 5.3.1 'Proportion of women aged 20-24 years who were married or in a union before age 15 and before age 18' gender and age are not disaggregations, but the sample required for the indicator.

The data represents the situation at the beginning of the respective reporting year.
