#### 3. Data description

• The time series is based on an assessment of legal frameworks that promote, enforce and monitor gender equality. The assessment is carried out by the Federal Ministry for Family Affairs, Senior Citizens, Women and Youth (BMFSFJ), using an international agreed questionnaire comprising yes/no questions under four areas of law:

i) overarching legal frameworks and public life;

- ii) violence against women;
- iii) employment and economic benefits; and
- iv) marriage and family.

Until 2020, there were a total amount of 45 questions. From 2022, four questions in area of law iii have been combined into one. This results in a total amount of 42 questions from 2022.
